
# **Rainbow Rider Transit**

**Future Needs – Buses** 

Rainbow Rider provides its service using a fleet of 36 buses, acquired from 2009 to 2017. All vehicles in the fleet are class 400 (medium-size light-duty transit bus) except for one, which is class 500 (medium-size medium-duty transit bus). Almost half of the fleet is in good condition, with most of the remaining in marginal or adequate condition. Five vehicles are in excellent condition as they were new purchases acquired in late 2018. Rainbow Rider has plans to make new vehicle purchases each year through 2025, which will gradually replace the entire fleet over the course of that period.

#### **Future Needs - Facilities**

Rainbow Rider is in need of a larger facility for bus storage in Alexandria. Their current facility only houses half of the buses that are needed in the area.

### **Budget Information**

In 2018, Rainbow Rider was awarded a grant from the State of Minnesota for approximately \$2.6 million in operating costs increased to \$2.9 million for 2019.
